I have reviewed the "Certificate of Mailing Special Election Ballots" and the "Certificate of Mailing Notification Letter," both executed on March 27, 2012 by Habib Isaac of Willdan Financial Services ("Willdan"), the contractor hired by the City to assist the City Clerk's Office in conducting the special mailed-ballot election within the Convention Center Facilities District No. 2012-1 listed above. I have also received a listing of all of the owners of land (each, a "Landowner"), as that term is defined in Section 61.2705 of the San Diego Municipal Code, entitled to cast a ballot in this election.

The time for the return of executed ballots has now passed. I have provided to Willdan, in an unopened condition, for the purpose of counting the ballots contained therein, all ballot envelopes received by my office by 8 p.m. on April 23, 2012.

On April 24, 2012, Willdan counted the special election ballots in the City Clerk's Office, and submitted to my Office a "Ballot Tally" that I have personally reviewed. Based on my review of Willdan's "Ballot Tally," I hereby certify the result of that count to be:
