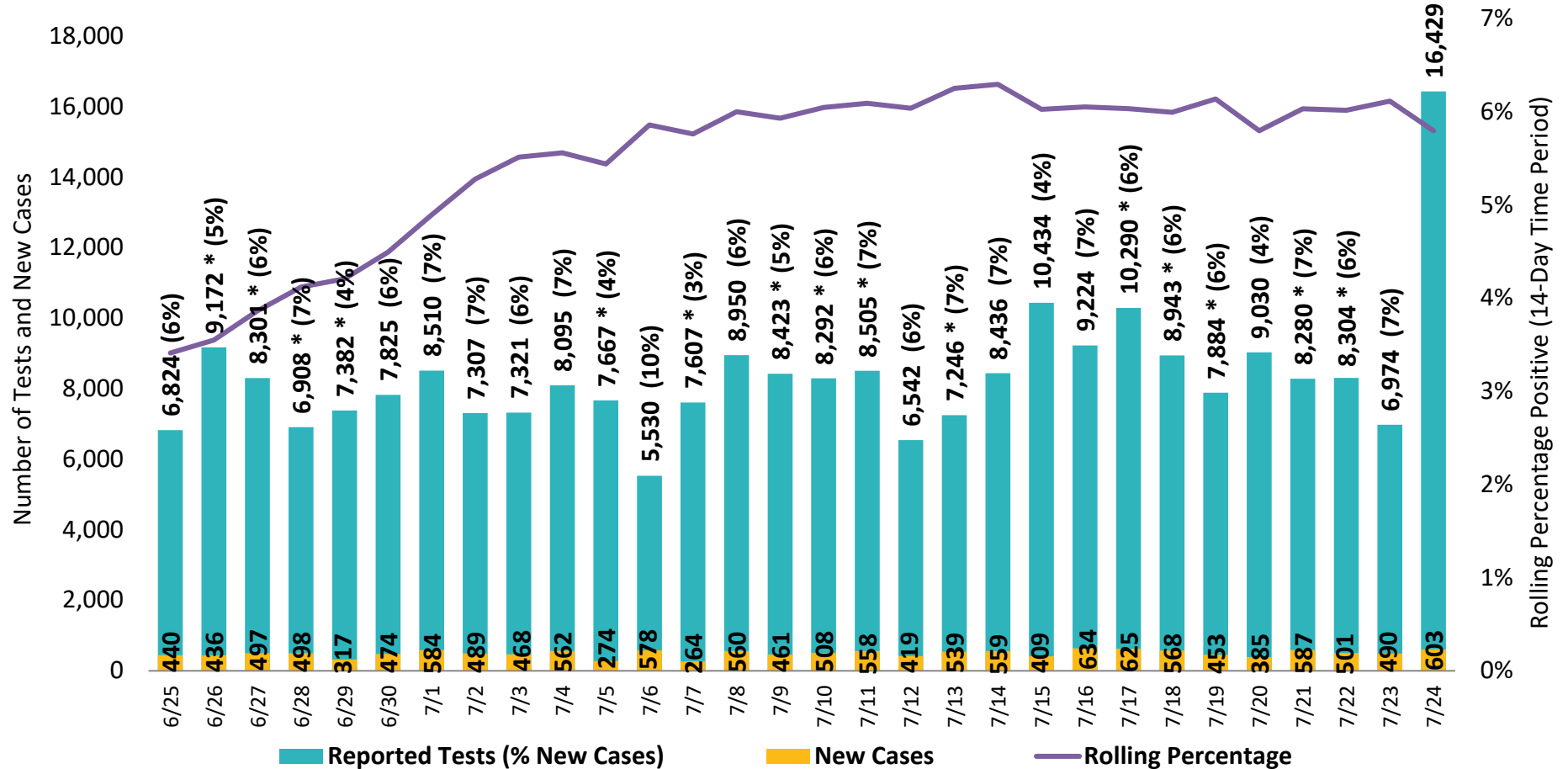


COVID-19 Percentage Positive

Total Number of Cases = 26,701



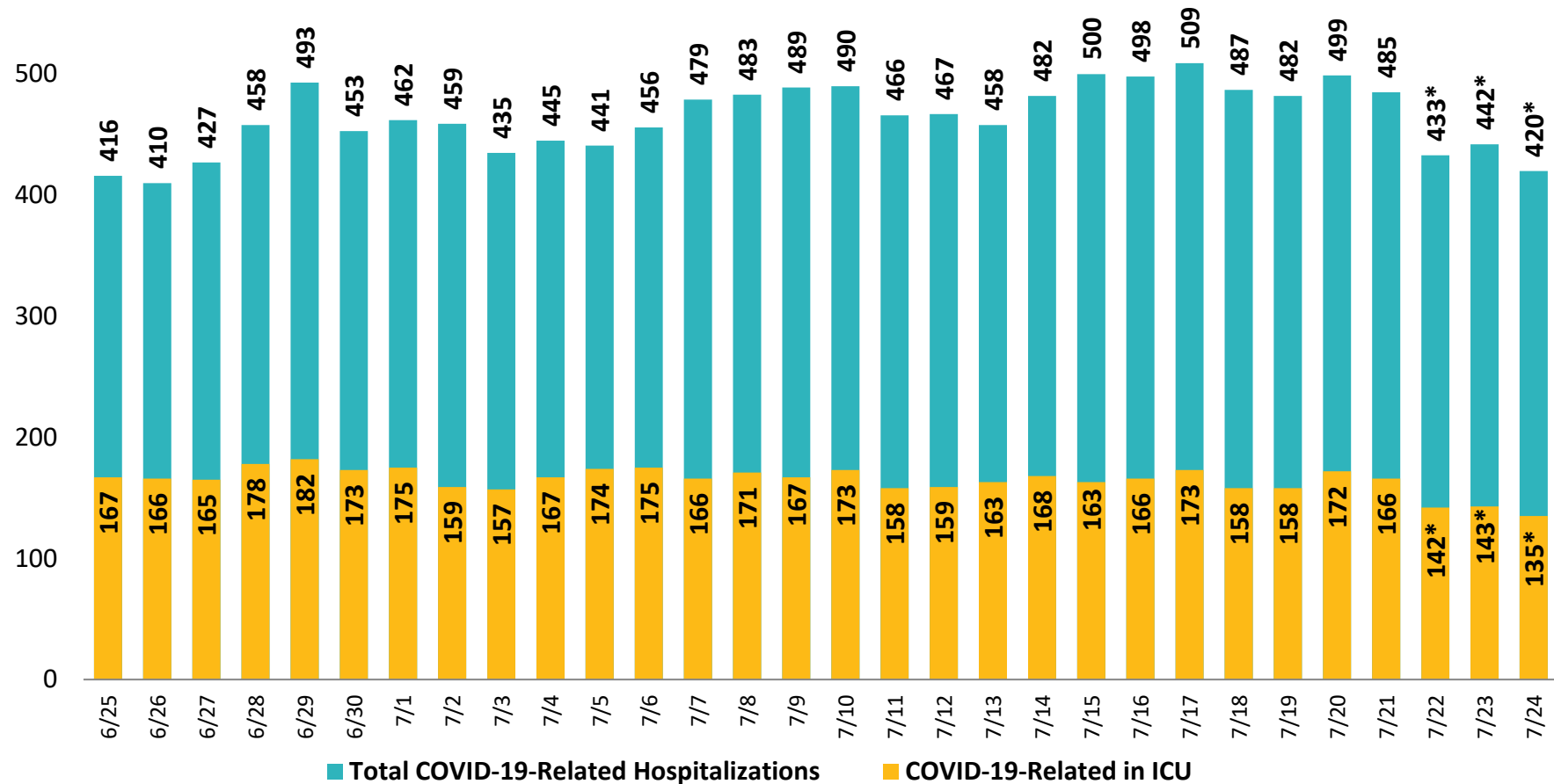

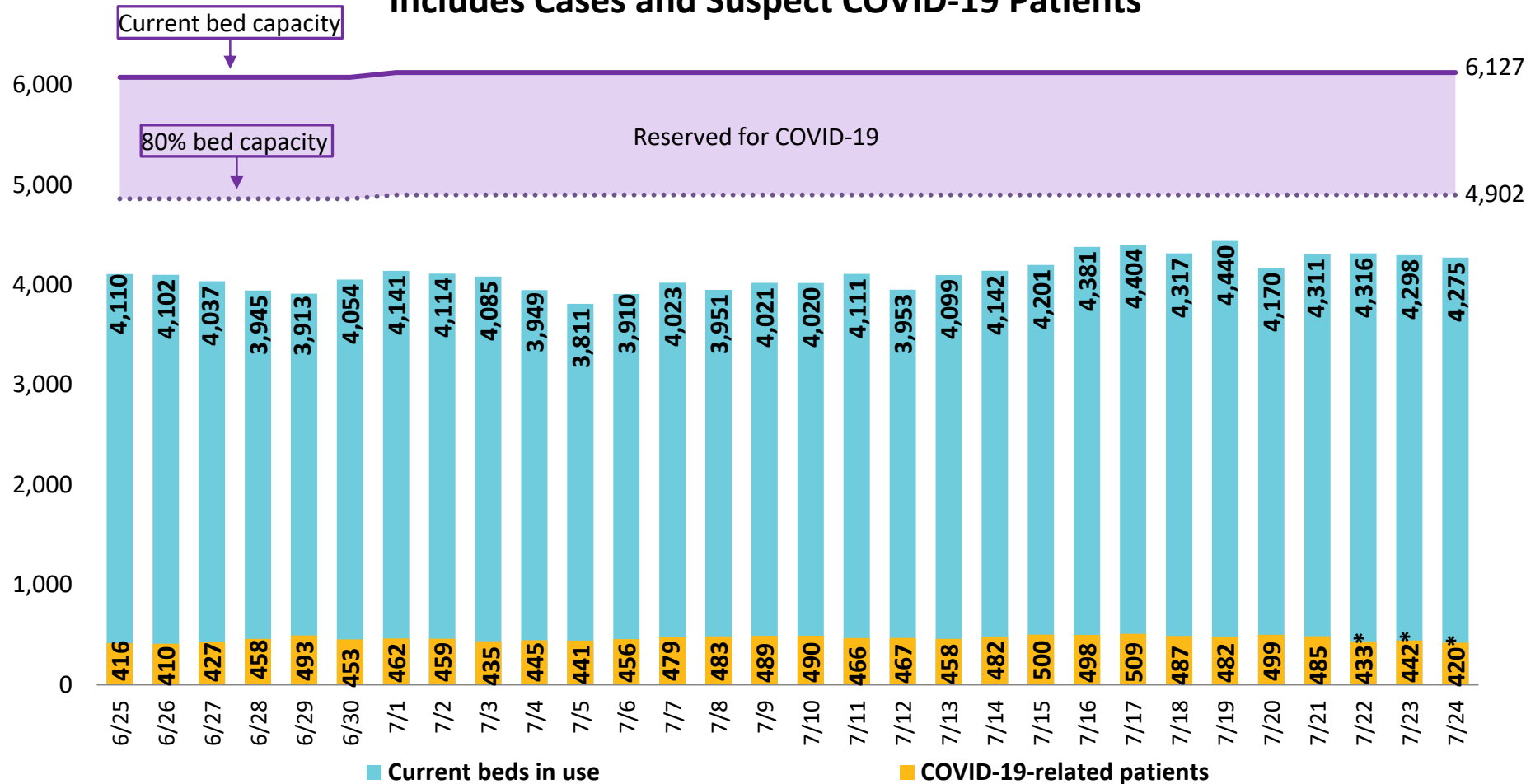

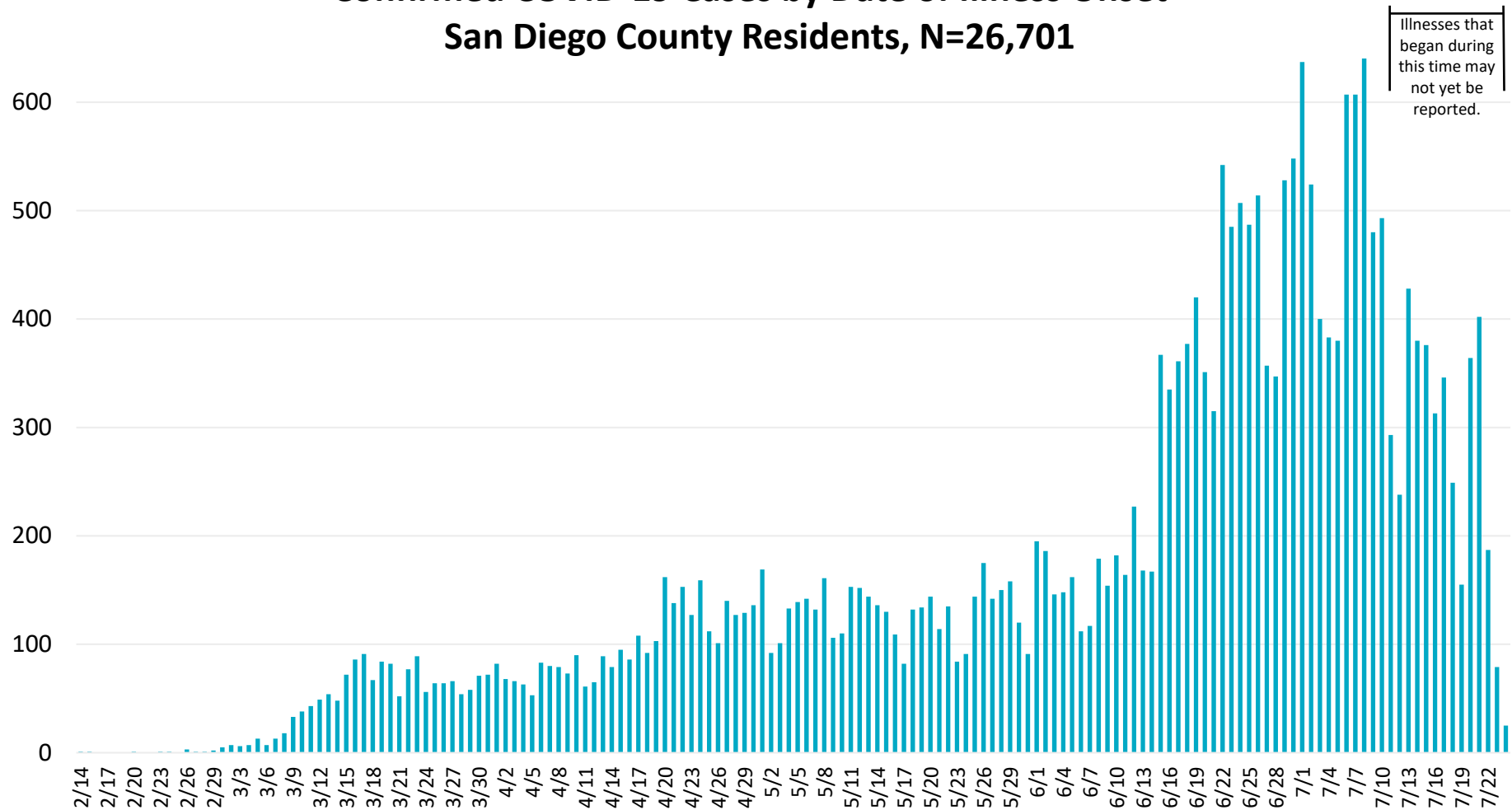

San Diego County Residents, N=26,701



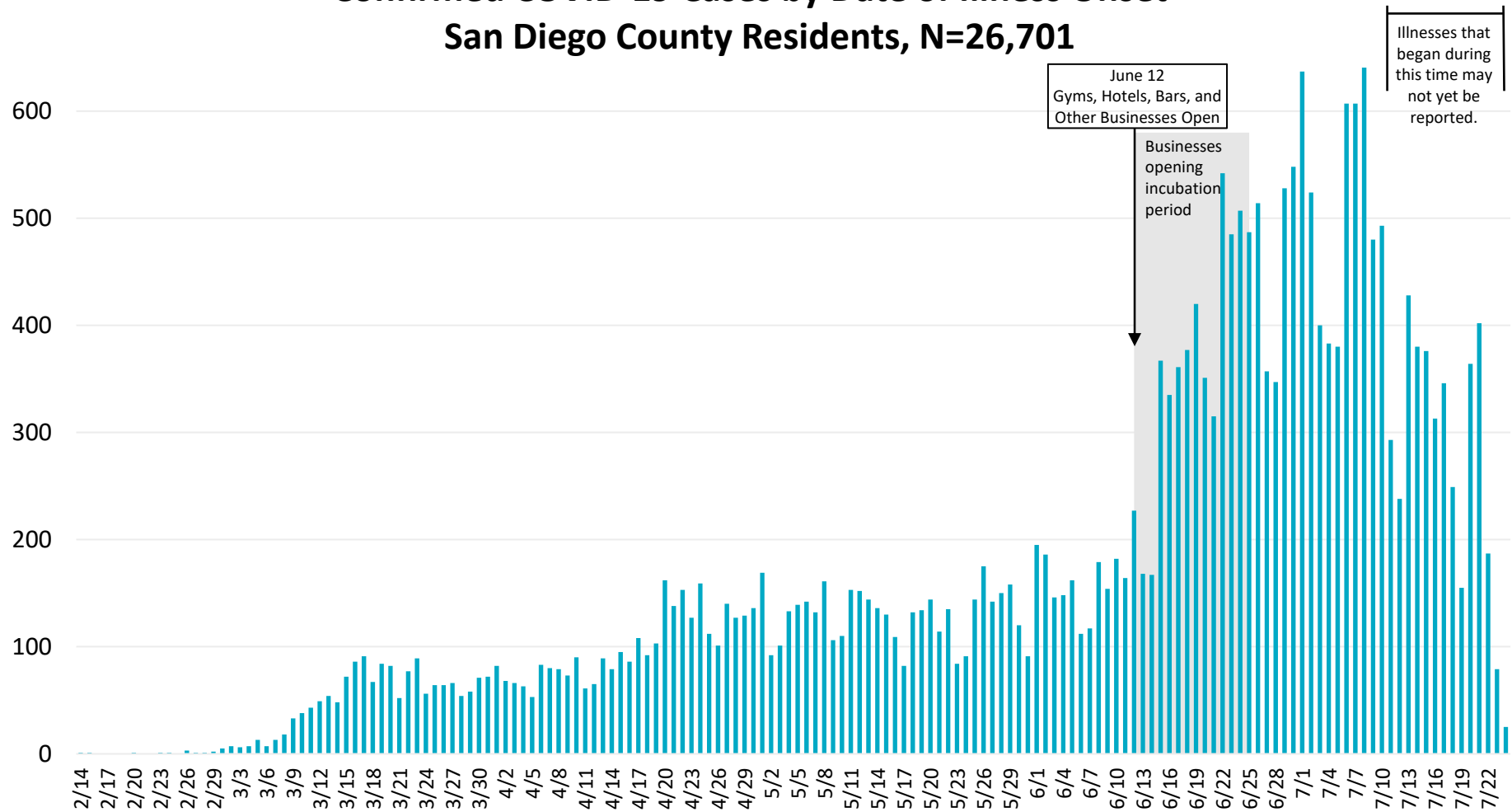

Confirmed COVID-19 Cases by Date of Illness Onset* San Diego County Residents, N=26,701



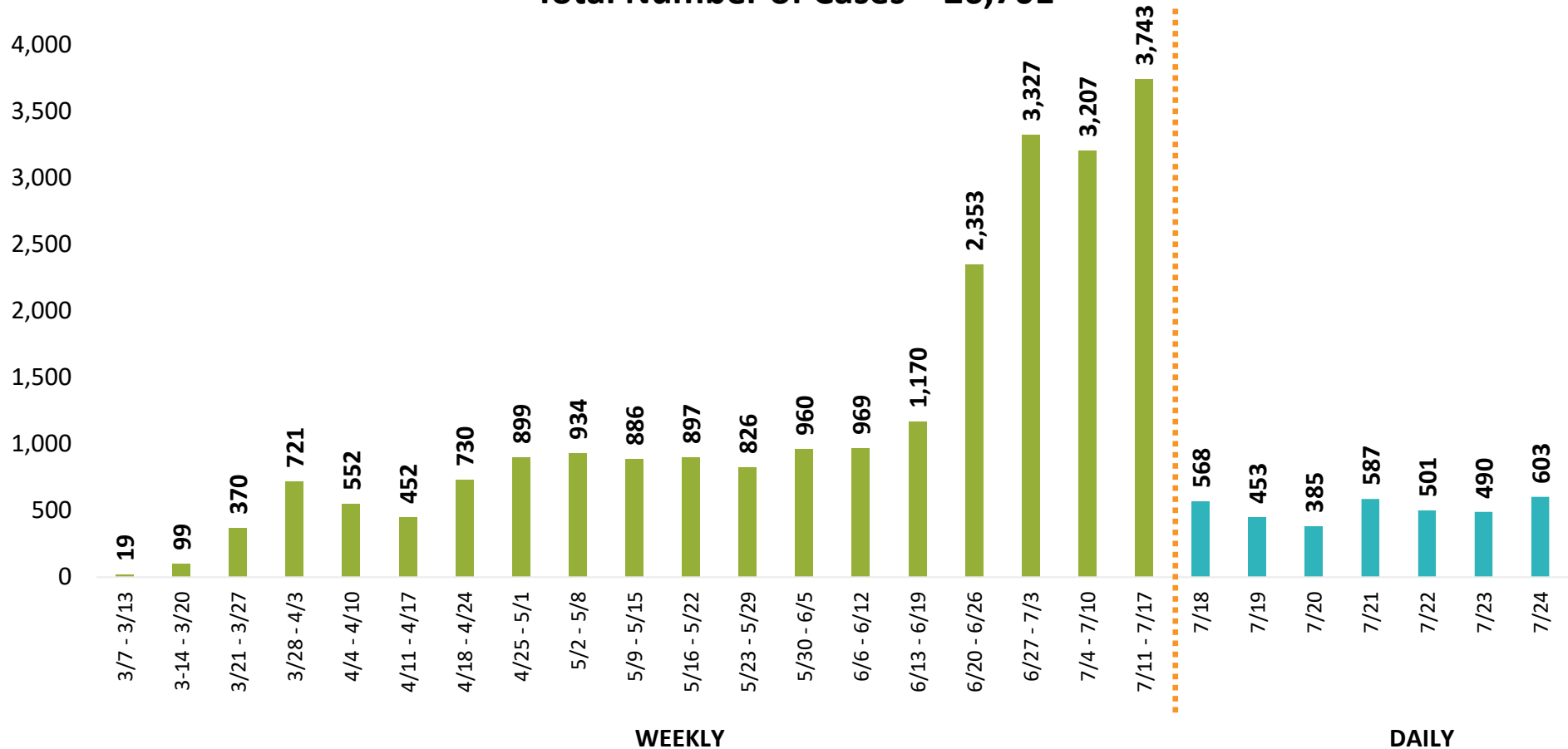

COVID-19 Cases Among San Diego County Residents New Cases by Date Reported Total Number of Cases = 26,701

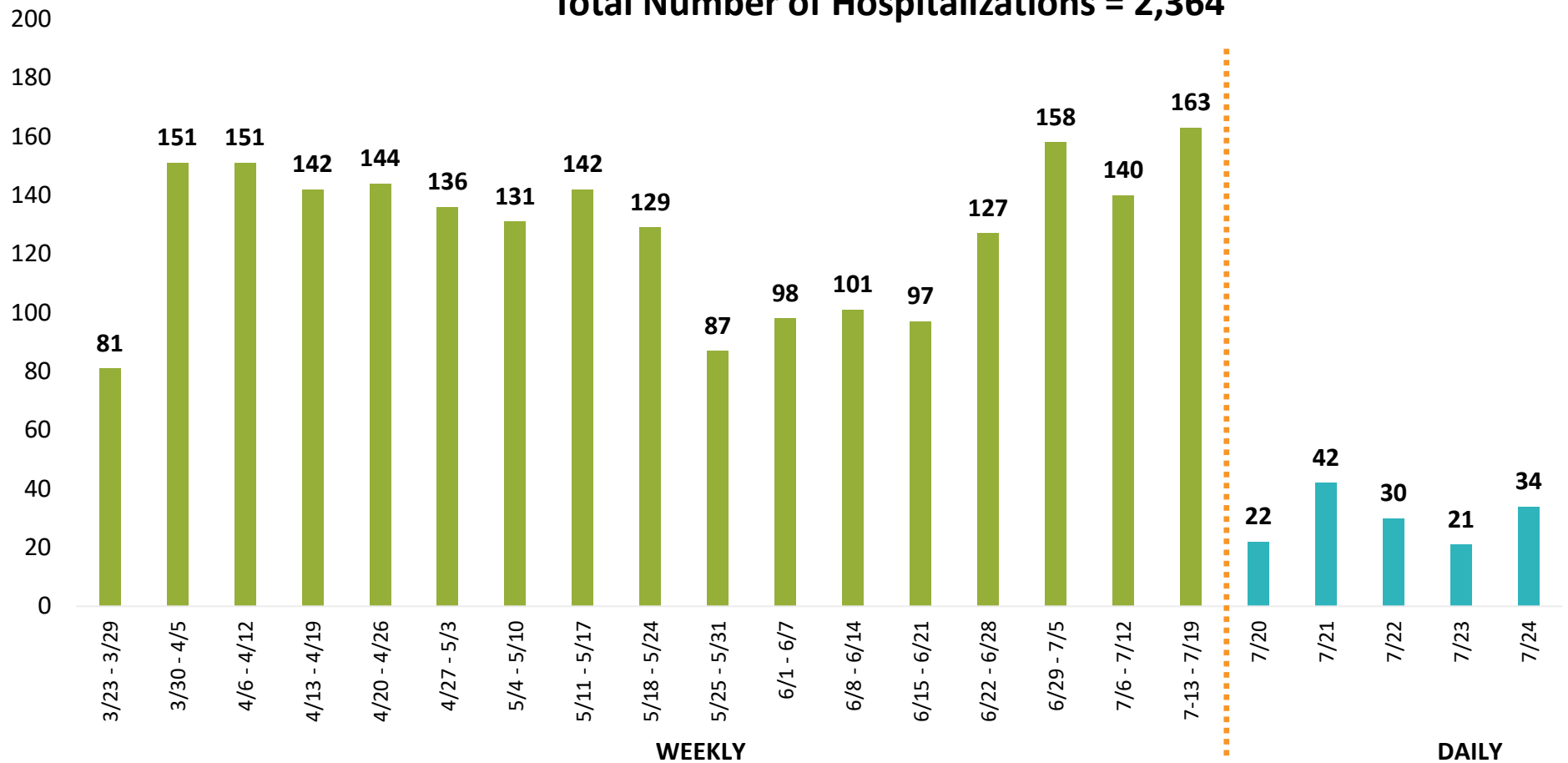

COVID-19 Confirmed Hospitalizations Among San Diego County Residents New Hospitalizations by Date Reported Total Number of Hospitalizations = 2,364

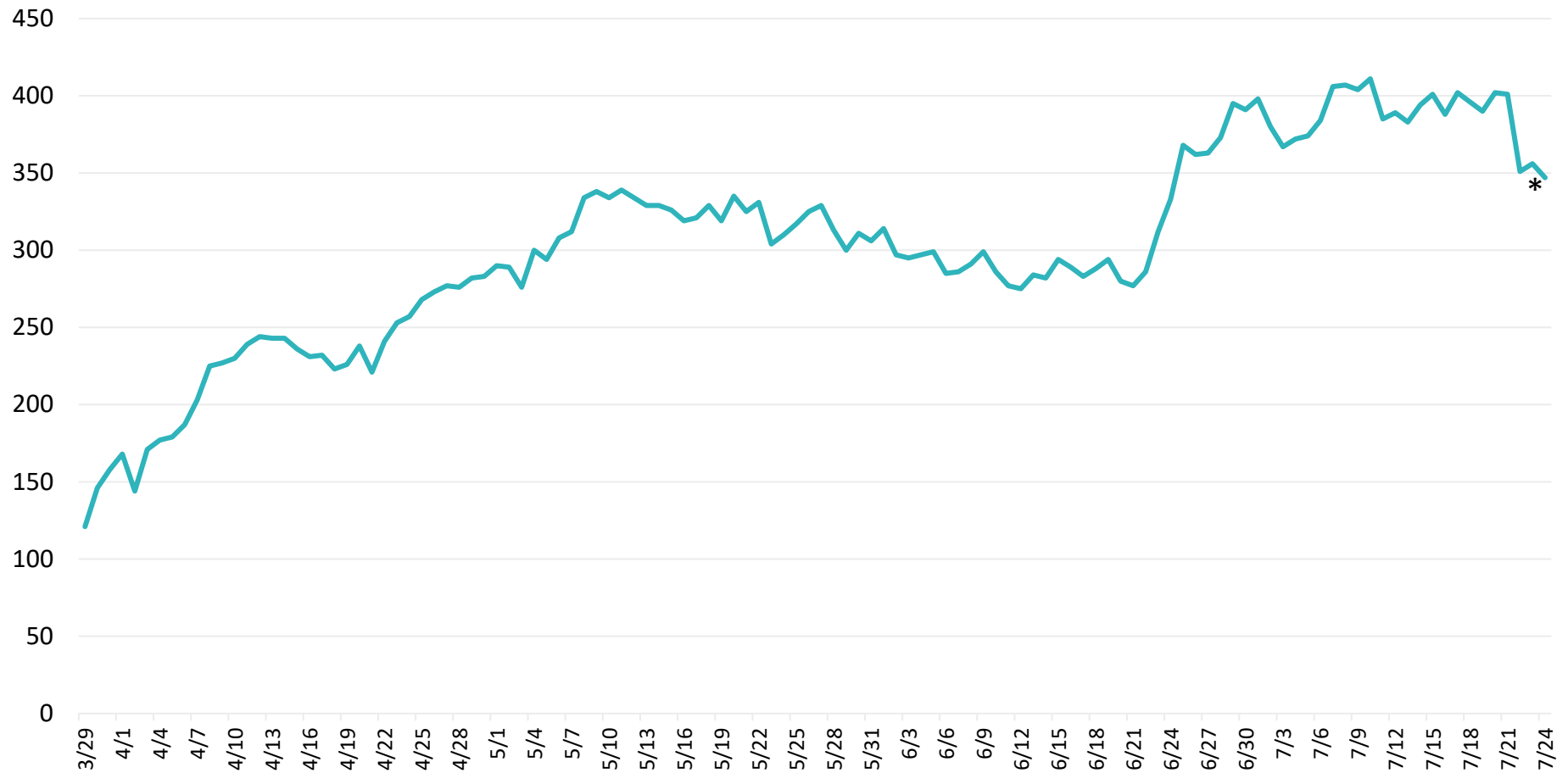

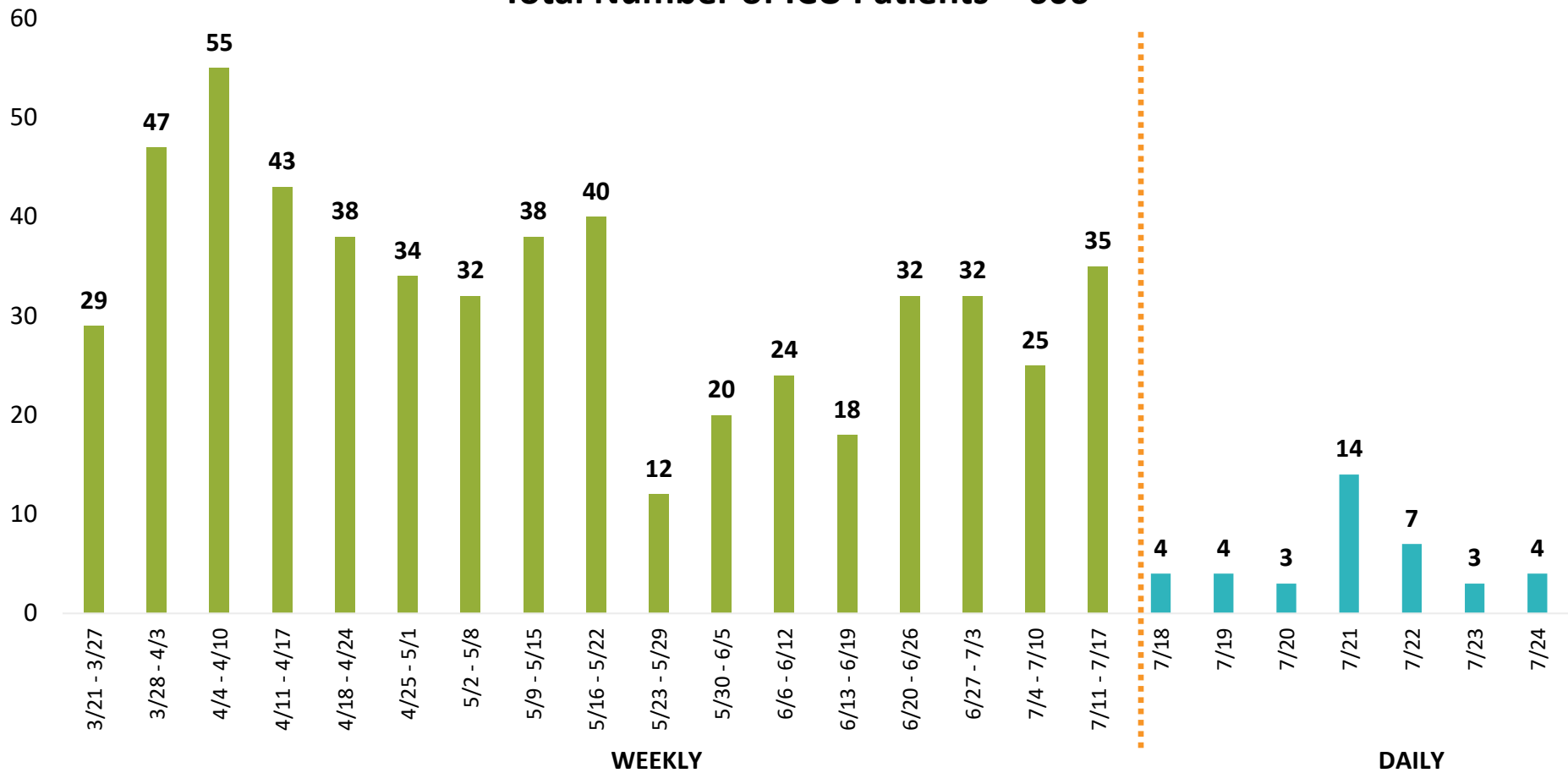

COVID-19 Confirmed ICU Patients Among San Diego County Residents New ICU Patients by Date Reported Total Number of ICU Patients = 606

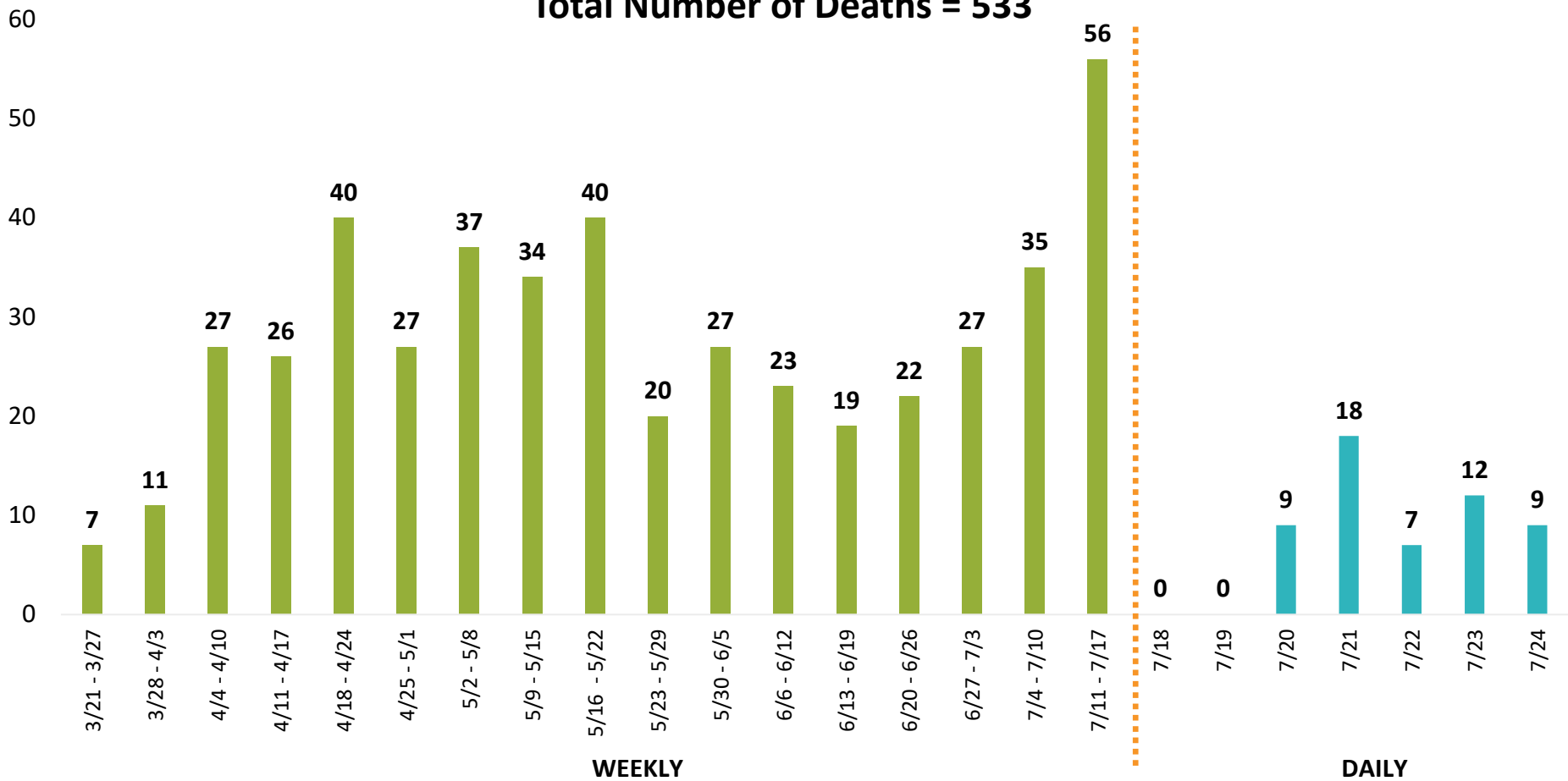

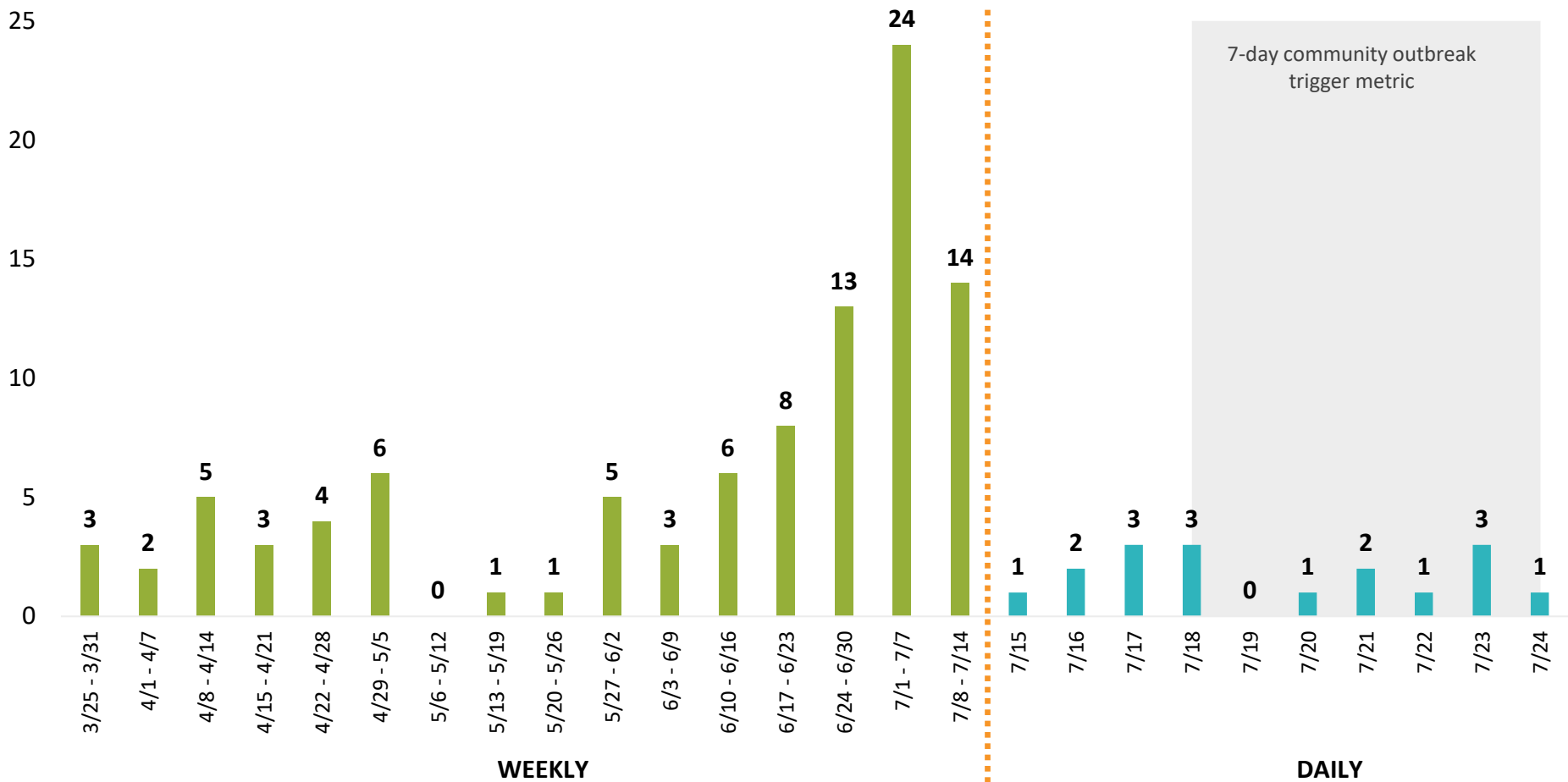

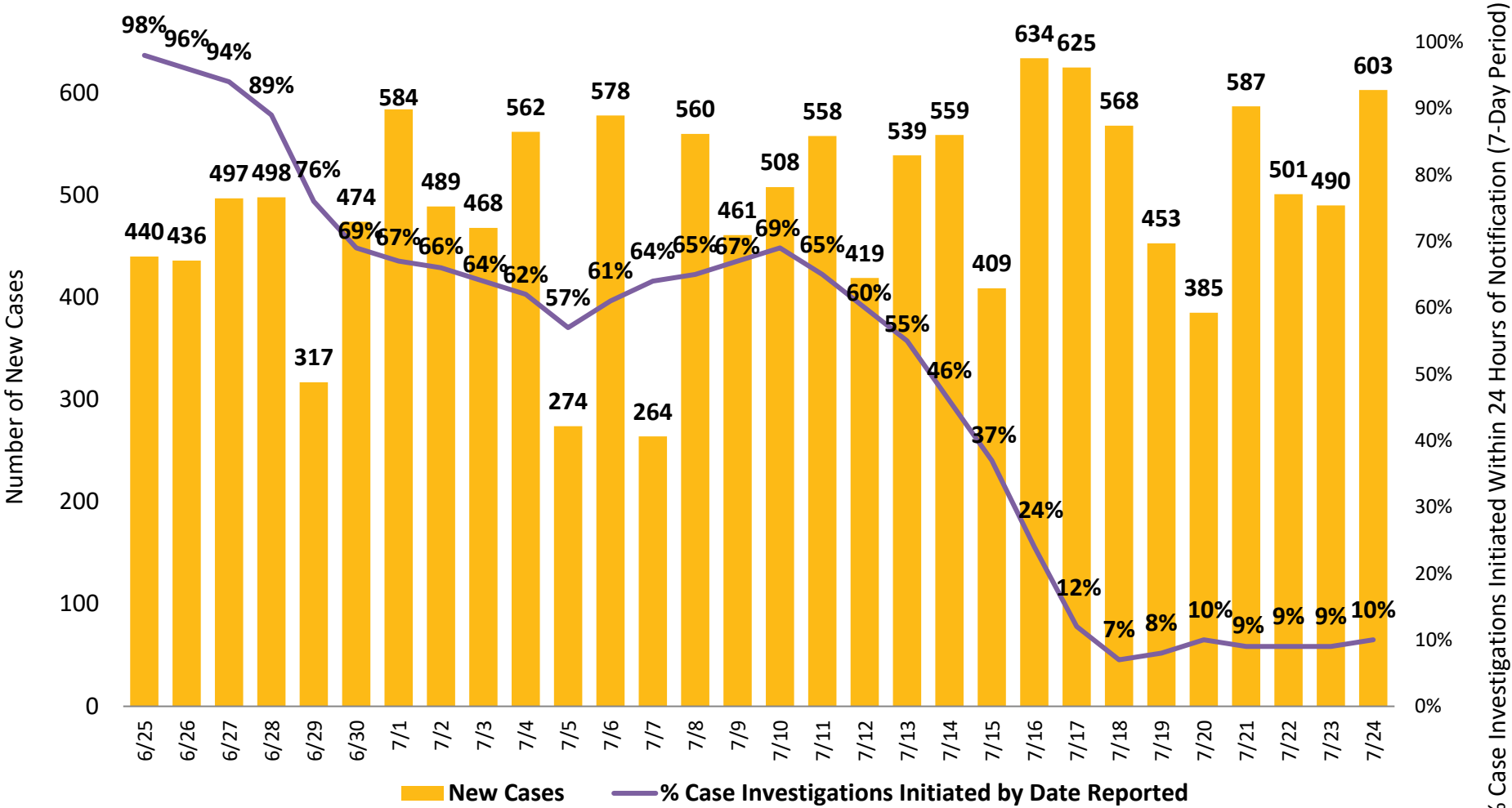


COVID-19 Community Outbreaks by Date Outbreak Confirmed Total Number of Community Outbreaks = 115

Positive Cases & Case Investigation Trigger

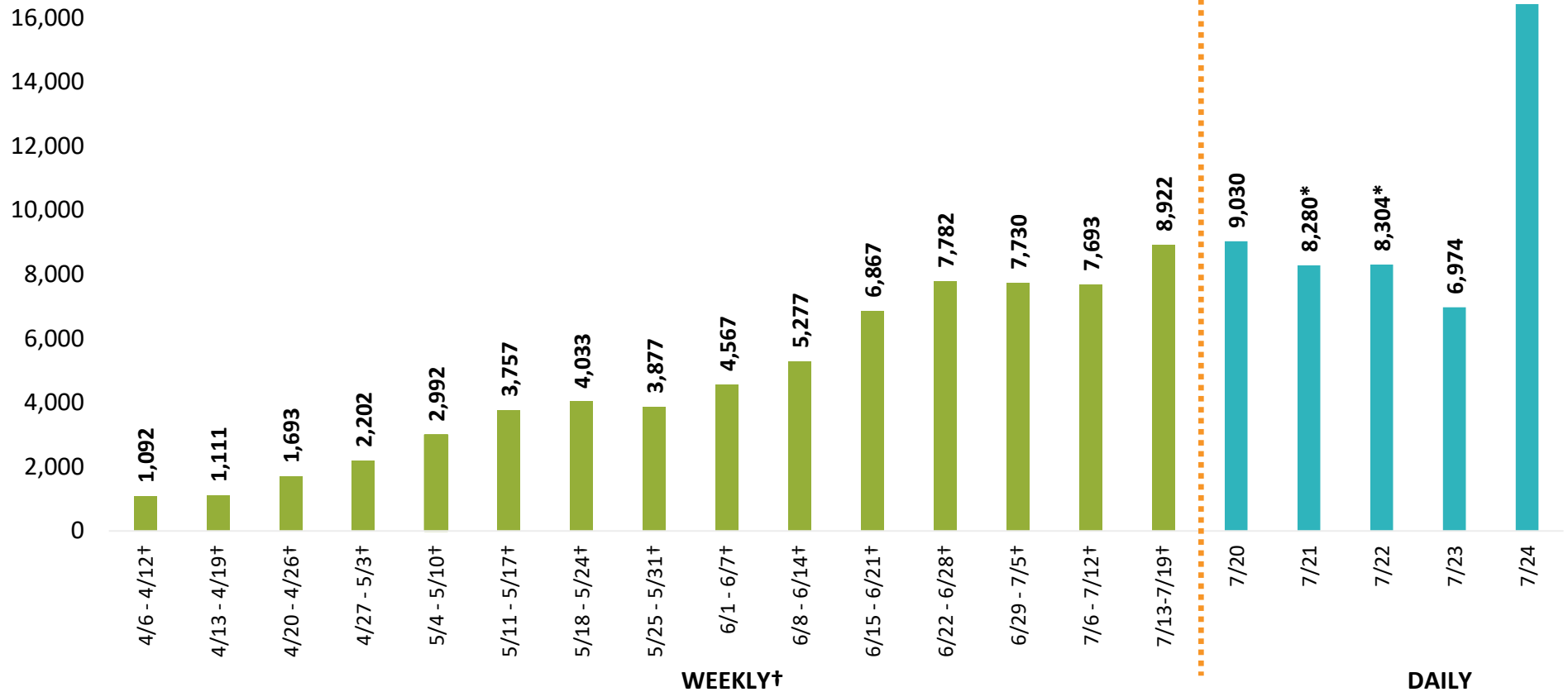

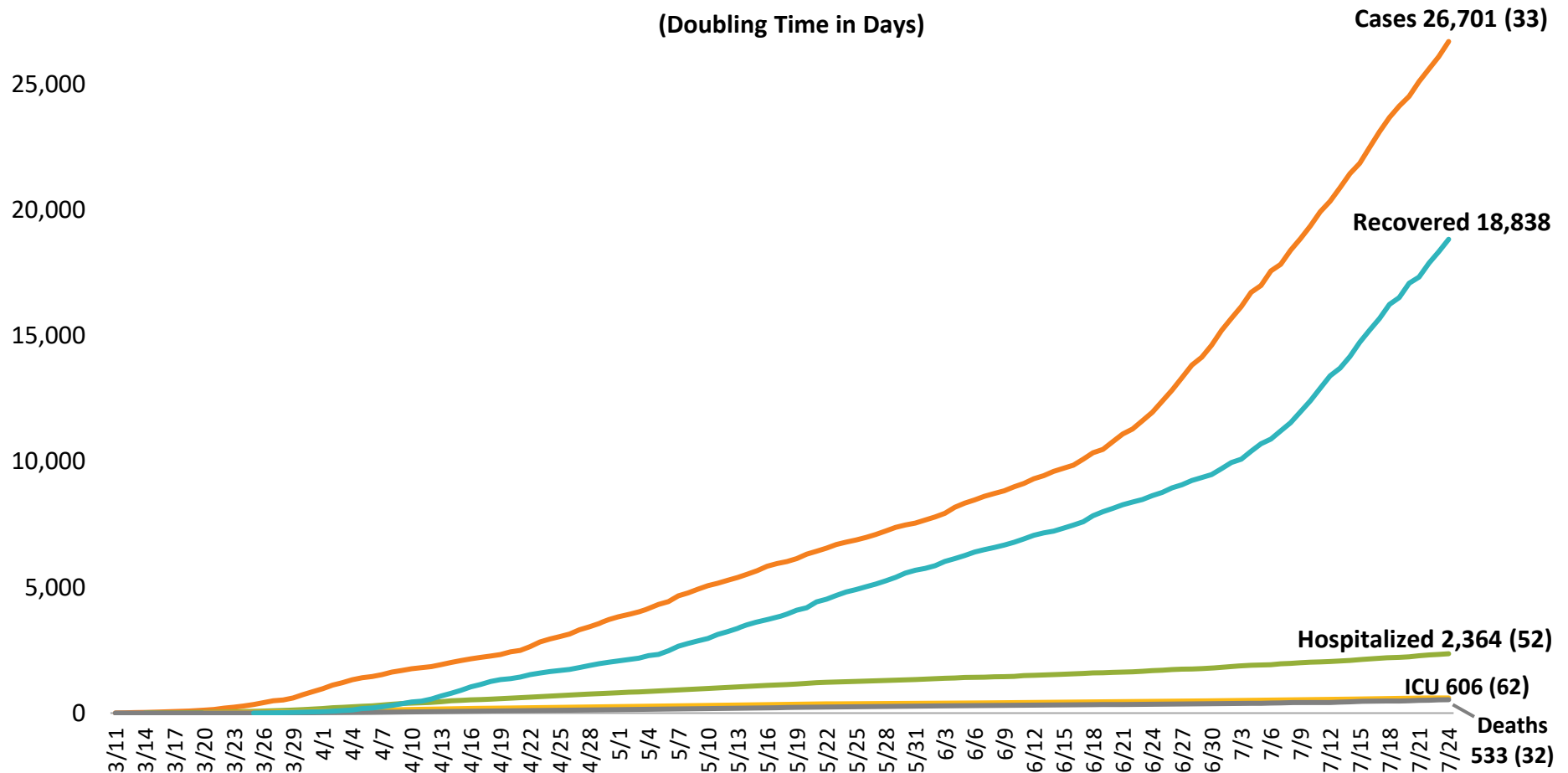
COVID-19 Totals and Doubling Time
